**CALL TO ORDER:** The meeting was called to order at 6:30 pm with the pledge of allegiance.

**APPROVAL of AGENDA:** Motion by Treasurer Patricia Tremble to approve the agenda. Supported by Clerk Michael Oxley. Voice vote: All yeas. No nays. Motion approved.

**ELECTION COMMISSION COMMENT:** Clerk Oxley spoke on the purpose of the meeting, required by law to approve the roster of election workers, worker pay and scheduling of the Public Accuracy Test for the Tabulator and Voter Assist Terminal (VAT) to be used on the Special Election Day (August 5<sup>th</sup>, 2025).

**PUBLIC ACCURACY TEST:** Motion made Oxley to have Supervisor Herzog and Clerk Oxley to perform the Public Accuracy Test of the voting equipment in the township hall on July 17<sup>th</sup>, 2025 at 9:00am. Motion supported by Tremble. Voice vote: All yeas. No nays. Motion approved. County Clerk Nancy Selle to post the public notice in the Arenac Independent. Clerk Oxley to post notice at the hall.

**ELECTION COMMISSION COMMENT:** Oxley thanked the other commission members for their time.
