CALL TO ORDER: The meeting was called to order at 9:00am with the Pledge of Allegiance

BOARD COMMENT: Aurette Gates and Donna Wilson were thrilled to see the agenda with little to do, especially after all the other planning commission meetings in the past months.

PLANNING COMMISSION MEETING DATES FOR 2026: Clerk Oxley stated that this was the time to change the meeting days/dates, should the board members wish to do so.
